#### NO AGENCY OR EMPLOYMENT RELATIONSHIP WITH THE ACADEMY 4.

The parties agree that no agency or employment relationship is created by this Agreement between the Academy and Presenter. Presenter is an independent contractor of the Academy.

#### 5. **INSURANCE**

Presenter shall obtain satisfactory insurance to support the obligations of Presenter under this Agreement, unless specific insurance is otherwise specified in an addendum or exhibit to this Agreement. If requested, Presenter shall provide the Academy with evidence of such insurance coverage.

#### 6. **NO ALCOHOL**

No alcoholic beverages, cans, bottles or glass containers of any kind shall be brought on the Premises.

## 7. COMPLIANCE WITH LAWS, REGULATIONS, POLICIES AND PROTOCOLS

Presenter shall perform the Agreement in compliance with all applicable federal, state and local laws, rules, regulations, and ordinances and Presenter represents that it and any personnel providing services hereunder has obtained all licenses and permits required by law to engage in the activities necessary to perform its obligations under the Agreement. In addition, Presenter shall comply with any additional policies, guidelines and/or protocols that may be in effect at Drexel that relate to the Engagement.

#### 8. PRESENTATION MATERIALS AND RELEASE

The Academy shall have the right to make and use photographs, motion picture films, videotapes and/or audio recordings made by the Academy, through its employees or agents, of the Engagement, including images of Presenter (collectively, "Presentation Material"), solely for the Academy's business uses, including, but not limited to, placing the Presentation Material on the Academy's Internet website or in any publication produced or sponsored by the Academy. By signing below, Presenter gives to the Academy an irrevocable, royalty-free, non-exclusive license to use, display, publish, exhibit, create derivative works from, and distribute all or portions of the photographs, films, videotapes, audio recordings and copies of images recorded from the Engagement, created by/for Presenter in connection with the Engagement and/or all Presentation Material consistent with this Agreement. The Academy shall not use Presenter's name and likeness for any commercial purpose or as an endorsement of the Engagement without Presenter's prior written consent.

## 9. INDEMNIFICATION AND RELEASE

Presenter agrees to defend, indemnify and hold harmless the Academy, its parent and affiliates, its trustees, officers, faculty, students, employees and/or agents from and against all actions, claims, demands, damages, expenses, and liabilities (including attorneys' fees) that arise from or are connected with the actions or inactions taken by Presenter. Presenter also releases and waives any and all claims, demands, or causes of action against the Academy, its parent and affiliates, its trustees, officers, faculty, students, employees and/or agents that arise from or are connected with the Engagement, any injury to Presenter and/or any invitees, guests or agents of Presenter, or damage to or loss of any property of Presenter that is brought upon the Premises, or exhibited, stored, or left upon the Premises by Presenter.

#### 10. SECURITY

The Academy does NOT provide security of any kind for the supervision or protection of any property of Presenter that is brought upon or exhibited, stored, or left upon the Premises by Presenter. Any property of Presenter left upon the Premises after the conclusion of the Engagement shall be considered abandoned and may be discarded by the Academy without recourse.

### 11. CANCELLATION

This Agreement may be cancelled by the Academy for any reason at any time prior to the Engagement.

### 12. ENTIRE AGREEMENT; APPLICABLE LAW

This Agreement constitutes the entire agreement between the parties and cannot be amended except in writing signed by both parties. This Agreement shall be construed and enforced in accordance with the laws of the Commonwealth of Pennsylvania and may be enforced in any state or federal court of competent jurisdiction located in the Commonwealth of Pennsylvania.

## 13. FORCE MAJEURE

In the event the Academy is unable to perform any of the terms or conditions of this Agreement due to events or causes outside the Academy's control, the Academy shall not be deemed to be in breach of this Agreement or liable to Presenter for costs or damages of any kind.

## 14. <u>AGENT'S WARRANTY</u>

If an agent is signing on behalf of Presenter, the agent signing below warrants that he or she is authorized to agree to each of the provisions of this Agreement on behalf of Presenter.
